II. Reviewed Board Positions Needed for Upcoming Elections (2 yr term beginning August 1, 2019).

New Judge Liaison

- Would like to see more detailed FAQ links on the website for potential judges in hopes to reserve the email contact for individuals committed to the pursuit of becoming a judge.
- Spend time with individuals preparing to test
- · Once an individual passes the test, it is recommended that they practice judge 3 times prior to getting assigned meets. It was suggested that a signed form be required for each practice judging session.
- · It was recommended that a walking meet ref. be assigned during the larger compulsory meets. The responsibilities of the walking meet ref. would include practice judging with the new judges to ensure they have adequate time to ask questions.
- Position will be a combined New Judge/Education for next term to include half time New Judge Liaison and half time Education.
